Orange County Community Action

Low-Income Home Energy Assistance Program (LIHEAP)

LIHEAP is a federally-funded program, providing financial assistance to low-income households in meeting the costs of home heating and cooling for Orange County residents.

To be eligible for LIHEAP, household income may not exceed 150% of the federal poverty level. This represents a gross income of \$17,820 per year for a household of one and \$36,450 per year for a household of four.

LIHEAP offers a yearly home energy credit to help eligible households in meeting the cost of home energy.

LIHEAP phone lines are open from 8:30 a.m. until 4:30 p.m. five days per week. Appointments are scheduled over the telephone by calling (**407-836-7429**) on the first and third Thursday of each month between the hours of 8:30 AM and 4:30 PM or until all the appointments are booked.

LIHEAP Home Energy Credit One benefit per calendar year:

This assistance helps eligible households in meeting the costs of home energy.

Example: If a client receives a Home Energy benefit on April 7, 2016, that client will not be eligible for another Home Energy benefit before April 8, 2017.

Benefits ranges from \$150 to \$475

Note - An emergency or crisis is not an eligibility requirement for this type of assistance.

LIHEAP Crisis Assistance

One benefit per LIHEAP Fiscal Year:

Cooling Season - April 1 - September 30 OR

Heating Season - October 1 - March 31

Benefit - \$600 maximum per fiscal year.

Note - Seniors 60 years or older cannot receive LIHEAP and EHEAP during the same Season.
