Crime Prevention Holiday Tips

PACKAGE THEFT

Ask your delivery company to place your packages out of view

Have a trusted neighbor pick up your packages

Place a hold on mail delivery before going on a trip

Take your holiday gift boxes (e.g., TV, computer, stereo, etc.) to one of the free Burglary Box Program recycle bins

HOLIDAY SHOPPING

Never leave gifts or valuables visible in your car

Do not become distracted. Stay aware of your surroundings

If it seems suspicious, Say Something

Stay alert for vehicles that may follow you home

Look for pedestrians at cross walks

Do not drive impaired. Have a designated driver
